

NOTICE OF MEETING TO VOTE ON TAX RATE

A maximum tax rate of \$0.3056 per \$100 valuation has been proposed by the governing body of the City of Fair Oaks Ranch.

PROPOSED TAX RATE	\$0.3056 per \$100
NO-NEW REVENUE TAX RATE	\$0.3056 per \$100
VOTER-APPROVAL TAX RATE	\$0.3565 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for the City of Fair Oaks Ranch from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval tax rate is the highest tax rate that the City of Fair Oaks Ranch may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that the City of Fair Oaks Ranch is not proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 2023 at 6:30PM at Fair Oaks Ranch Public Safety Building, 7286 Dietz Elkhorn, Fair Oaks Ranch, TX 78015.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, the City of Fair Oaks Ranch is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of Fair Oaks Ranch at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The members of the governing body voted on the proposed tax rate as follows:

FOR: Mayor Maxton, Council Members Stroup, Rhoden, Bliss, Koerner, Parker and Muenchow

AGAINST: none

PRESENT and not voting: N/A

ABSENT: N/A

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by the City of Fair Oaks Ranch of last year to the taxes proposed to be imposed on the average residence homestead by the City of Fair Oaks Ranch this year:

Average homestead taxable value	\$566,488	\$626,093	increase of 10.52%
Tax on average homestead	\$1,864	\$1,913	increase of \$49 OR 2.63%
Total tax levy on all properties	\$7,043,398	\$7,298,208	increase of \$254,809 OR 3.62%
